NOTIFICATION

Whereas it has come to the notice of the undersigned that plying of trucks/trailer having more than 10(ten)wheels carrying Iron Ore, Chrome, Coal ,Oil Trankers & Other Minerals on SH-09A from 2/0Km at Chandol to Kanika of Cuttack -Chandabali road , are not only damaging the road , but also causing inconvenience to the general public and giving rise to the vehicular congestion on such route.

Now therefore , I Sri Pradipta Kumar Patnaik ,IAS , Collector & District Magistrate-Cum-Chairman ,RTA , Kendrapara ,being satisfied that it is necessary in the interest of public safety and convenience to restrict movement of such heavy commercial vehicles (trucks) on the above mentioned road , in exercise of powers conferred on me u/s 115 of MV Act, 1988 read with rule 173 of Orissa Motor Vehicle Rules ,1993 , do hereby restrict.

1. Movement of heavy commercial vehicles(trucks) having 10(ten) wheels or more , carrying iron ore , or other minerals and Oil Tankers(Except bound to outlets in Kendrapara District) SH-9A(FROM CHANDOL TO KANIKA ON CUTTACK-CHANDABALI ROAD)
2. The restrictions, however will not be applicable to commercial vehicles used for essential services and for construction and repair of the road in the locality within Kendrapara district .

THESE RESTRICTION WILL COME INTO FORCE FROM 11.05.2011 to 10.09.2011


